Ažurirane definicije pojmova „škola“ i „tijela lokalnih / regionalnih vlasti nadležnih za škole“ u okviru programa Erasmus+

1. Definicija pojma „Lokalne i regionalne vlasti nadležne za škole koje su prihvatljive kao koordinatori konzorcija u aktivnosti KA1, Mobilnost školskog osoblja, te kao koordinatori ili partneri u aktivnosti KA2, Strateška partnerstva za regionalnu suradnju“ glasi:

„Tijela lokalnih/regionalnih vlasti nadležna za škole uključuju tijela lokalne ili područne (regionalne) samouprave s ulogom u obrazovanju (općina, grad, županija).“

2. Definicija pojma „Ostala tijela koja su prihvatljiva kao koordinatori konzorcija u aktivnosti KA1, Mobilnost školskog osoblja“ glasi:

„Ostala tijela koja su prihvatljiva kao koordinatori konzorcija u aktivnosti KA1, Mobilnost školskog osoblja su Agencija za odgoj i obrazovanje, Agencija za strukovno obrazovanje i obrazovanje odraslih te Nacionalni centar za vanjsko vrednovanje obrazovanja.“

3. Definicija pojma „Škole koje udovoljavaju uvjetima formalne prihvatljivosti kao organizacije koje šalju ili primaju sudionike u aktivnosti KA1, Mobilnost školskog osoblja te kao koordinatori ili partneri u aktivnosti KA2, Strateška partnerstva u kojima sudjeluju samo škole“ glasi:

„Odgojno - obrazovna ustanova, osnovana sukladno zakonu koja posjeduje rješenje o početku rada izdano od strane zakonom ovlaštenog tijela. Navedeno obuhvaća: dječje vrtiće, osnovne škole, srednje škole, učeničke domove te druge javne ustanove koje posjeduju rješenje o obavljanju djelatnosti odgoja i obrazovanja.“

Updated definitions of terms „school“ and „local / regional authorities responsible for schools“ under Erasmus+ programme

1. The definition of term „Local / regional school authorities eligible as consortium leaders for KA1 Mobility of School Education Staff and as coordinators or partners for KA2 Strategic Partnerships for regional cooperation“ is:

“Bodies of local / regional authorities responsible for schools include bodies of local authorities or local (regional) self - government with a role in education (municipality, city, county).”

2. The definition of term „Other school coordinating bodies eligible as consortium leaders for KA1 Mobility of School Education Staff“ is:

„Other school coordinating bodies eligible as consortium leaders for KA1 Mobility of School Education Staff are Education and Teacher Training Agency, Agency for Vocational Education and Training and Adult Education and National Centre for External Evaluation of Education.“

3. The definition of term „Schools eligible as sending or receiving organisations for KA1 Mobility of School Education Staff and as coordinators and partners for KA2 Strategic Partnerships involving schools only“ is:

"Educational and / or training institution that was established in accordance with the law and that holds a certificate on the commencement of work, issued by the legally authorized body. This includes kindergartens (institutions of pre - primary education), elementary schools (institutions of integrated primary and lower secondary education), secondary schools (institutions of upper secondary education), student dormitories and other public institutions that hold a license for the performance of education and training activities."
