Interested persons should address the Ministry of Foreign Affairs or the Ministry of Education of their country of origin, which are competent for application collection, the proposed candidates' selection and the forwarding of the files to our Office.

The proposals of each country, along with the proposed candidate files should arrive in our Office no later than **June 17**<sup>th</sup> **2016.** However, it is noted that each country shall determine by itself the closing dates for application submission which shall not coincide to the final closing date of file consignment to Greece and interested persons should address the services of their own country, for filling of the application.

Our Office shall notify the competent authorities with the scholarship approval decision for the proposed persons for the summer seminar of 2016, no later than **June 30<sup>th</sup> 2016** (on the condition that candidate files are full).

It is not permitted to grant a scholarship to candidates receiving scholarship from another public Greek entity or/and from the European Union. Candidates who have already received scholarship from the Greek Government within the framework of Bilateral Educational Programs are not entitled to apply for a new scholarship. To the summer seminar shall be accepted candidates born after 1.1.1974.

The place and date of the seminar shall be notified no later than May 30<sup>th</sup>, 2016 by a new document of our Office.

The scholarship shall cover all expenses (tuition fees, accommodation, food allowance, boarding of scholars, as well as their participation in cultural events), except for traveling expenses to and from the country, which shall be undertaken by the scholars themselves or their home country.

#### B. Supporting Documents

- Application (form provided by our Office).
- A photocopy of ID Card or passport for the citizens of countries within European Union.
- -A photocopy of passport for countries outside European Union.
- One (1) colour identity card photo, affixed on an application form provided by our Office.

- Certificate of knowledge of the language(s) that the candidate states that he/she knows.
- Qualifications (Titles) of studies.
- Curriculum vitae.
- A recent health certificate to certify that the candidate does not suffer from an infectious disease (for countries outside European Union).

All supportive documents are submitted officially translated in Greek, French or English language in two(2) copies. In case of submission of false, forged or supporting documents insufficiently completed, candidacy shall be rejected without notice by our Office. Rejected candidates' supportive documents shall be returned upon request within one (1) year from the date of their submission.
